Public Notice

Counselling for admission to MBBS/BDS courses in all Government/ Government Aided/ Private Unaided Medical/ Dental Institutes including those under Private Universities - SGT University, Budhera, Gurugram, PDM University Bahadurgarh, Jhajjar and Al Falah University Faridabad in the State of Haryana for the Academic Session 2019-20.

It is for the information of all the eligible candidates desirous of seeking admission to UG (MBBS/BDS) courses for the academic session 2019-20 and all other concerned that fresh registration for second round of counseling for admission to UG courses for the academic session 2019-20 shall be held as per following schedule:-

- The candidates, who have already registered themselves for the first round and wish to participate in the second round, shall not be required to register again. The candidates who have got their document verification done during the first round of counseling are not required to get documents verified again.
- The candidates who have joined on the allotted seats in the first round of counseling shall have to give their willingness/option to upgrade themselves in the second round of counseling online otherwise they shall not be considered eligible for the second round of counseling.
- The candidates who have been allotted seats in the first round but did not join the allotted seat will also have to give their willingness to participate and submit fresh choices for the second round.
- The Candidates who have joined on the allotted seat in the first round shall have a right to already allotted seat and this shall be changed only if he/she gets an updated and opted seat during second round. However, the candidates who wish to participate in the 2nd round of online counseling will have to submit their preferences/choices afresh. Candidates, who have been allotted, seat in first round should give the fresh choices in order of preferences for the seats in which they wish to upgrade themselves.
- All candidates, excluding PWD candidates {already registered (irrespective of their admission status) and freshly registered candidates} who wish to participate in the second round of counseling and want to opt for Government/Government aided Medical/Dental Institutes shall have to deposit online a sum of Rs.10,000/- (Rs.5000/- for SC/BC/EWS of Haryana state) and if the candidates wishes to also opt for Private Medical/Dental Institutes including Private Universities then he/she shall have to deposit online a sum of Rs 1.00 Lakh. The candidate can deposit the amount online on uhsugadmissions.in using their log-in ID and password from 23.07.2019 to 30.07.2019 (till 11:59 PM).**

In case, the candidate for any reason is not able to deposit the amount online, he/she can submit the above amount in the shape of demand draft in favour of Controller of Finance, Pt.B.D.Sharma University of Health Sciences, Rohtak to the Admission Committee. The demand draft will have to be deposited to the Chairman Admission Committee between 23.07.2019 to 30.07.2019 (upto 5.00 PM) either by the candidate himself or through authorized representative.

The candidates who wishes to participate in 2nd round must deposit the requisite amount - Rs.10000/- (Rs.5000/- for SC/BC/EWS of Haryana state) or Rs.1.00 Lacs as the case may be, failing which they will not be considered eligible to participate in the 2nd round of counseling. This amount shall be later on adjusted in the fee of the first year of UG Course. The amount deposited by the candidates who are not allotted seats during the 2nd round shall be returned after the completion of the counseling process.

- f) The candidates who are allotted seat in the 2nd round of counseling but do not join, their amount of Rs.10000 (Rs.5000/- for SC/BC/EWS of Haryana state)/Rs.1.00 Lakhs shall stand forfeited, however they will be eligible to participate in the mop up round.
- g) **The candidates who join the seat allotted to them during the All India 2nd round/ Any State counseling shall not be eligible to participate. The candidates will have to give an undertaking online for the same and this option will be available on the login of candidates from 26.07.2019 to 29.07.2019(11:59 PM) failing which the candidature of the candidates will not be considered.**

Note:-

- The choices filled by the candidates for the first round of counseling shall be treated as null and void and the candidates will have to fill fresh choices to be eligible for participating in the second round of counseling.
- Seat matrix for the 2nd round of counseling will be displayed only when the vacant seats from the All India Quota are reverted to the State.
- If a candidate does not report for document verification or does not deposit the demand draft as explained above he/she will be considered ineligible.
- The above instructions should be read alongwith the Notification dated 21.6.2019 & any subsequent Notifications issued thereafter.
